- f) **“Complied Object”** means a collection of literary or artistic works (such as encyclopedias, anthology and periodical editions), database, or performances, phonograms, videogram, programs of broadcasting organizations or other works, in which selection and arrangement of the contents is the result of intellectual –creative efforts of its complier. An Object that constitutes a Complied Object will not be considered a Derivative Object for the purposes of this License.
- g) **"Creator"** means an individual who created an Object by his/her intellectual-creative effort. For the purposes of this License the Creator should also be taken to mean the performer, videogram and phonogram producer and broadcasting organization, producer of a database.
- h) **"Reproduce"** means to make in whole or partially, directly or indirectly one or more copies of the Object by any means and in any form including without limitation by sound or visual recordings. If the Licensee creates a Derivative Object, upon notice from any Licensor the Licensee must, to the extent practicable, remove from the Derivative Object any reference to such Licensor or the Creator as required by Section 4(d), as requested, by referring to such removal.
