## **Advisory Review**

## Commercial Development / Public Art Element

We are proposing a review process that stays inline with our current charge from Town Council. This review would provide a clearer picture to our review and give additional guidance. The fear of Council is that they would become inundated with additional information that they currently do not have time for. The new review process will avoid that. This new review would be limited to a single page document. Most importantly, this is an Advisory Review only. CHPAC will not be authorized or exercise a yay/ nay vote on any art presented to us. This review will allow us a forum to properly comment on the art. Note the location of the installation and comment on all elements pertinent to the Town of Chapel Hill.

The concerning issues for CHPAC in reference to this issue are many. First, making sure that submittals of these art installations fall within a unified vision of the public art collection that belongs to the Town. Second, we wish to avoid situations where we have art for arts sake and begin loosing the quality of the pieces. Third, the life safety that comes with any public / private installation. When dealing with sculptures, we need to consider life safety, vandalism, and general maintenance. Who will clean graffiti off of the piece, who will repair rusting steel sculptures, who will cut an abandoned bicycle lock off of a part of a sculpture. It is answers to all of these questions that have moved us to propose the reworking of the Courtesy Review.
