Brown will organize videotaping process for events; Bosman will share w/ CHPAC 3 potential questions to use at the events' comment wall; and Cultural Arts will provide tents, tables and cards printed w/ survey URL at these events. Committee and Staff Reports and Updates	Kass described the selection meeting for the Crosswalk project and selected designs were shown. York announced Sept. 11 from 6:30 – 8 is the Scrapel Hill opening night. Wilson discussed potential theatre program likely to occur spring 2016; York will need to know if program is going to happen by Oct. 1 if Artist Residency program funds are to be used. Wright showed images of new Juried Exhibitions artists selected for this fiscal year and photos of some sited Sculpture Visions pieces. Kass proposed the formation of three work groups to cover youth programs, the Permanent Collection, and exhibitions and special events; non-Commissioners are encouraged to join these groups.
