Goal: 20 art installations, 1,000 attendees. TOCH task team has approved event, as has Carrboro. \$52K budget, Cultural Arts asked to invest \$10K; Visitors' Bureau \$2.5, Downtown Partnership \$1K, other sponsors sought. \$35 artist app fee, ea. selected artist will be paid \$300 at least.
