Planning Update	Ben Hitchings, Director of Planning and Development Services, made a presentation about the work of the Planning Department and how it may intersect with the work of the Cultural Arts Commission and Division. He discussed the guiding principles of protecting and creating great places and engaging the public proactively. 	if any art would be integrated into the Chapel Hill High and Lincoln Center projects, and how the Downtown Development Guidelines would integrate public art. Williams said public art is also platforms and spaces where art takes place or is made, and that the Town should plan for spaces for performing and making. Cefalo said developers need a wider spectrum of artistic possibilities, some of which may be less expensive than traditional public art sculpture, and stressed the importance of art being integrated into part of planning and development discussions. Knight suggested a Chapel Hill "walk of fame" similar to Hollywood's, perhaps as part of the upcoming downtown alley renovations.

Creative Projects	Four of eight proposals were recommended for partial funding: \$750 for arts-related activity at the Northside festival sponsored by the Jackson Center; funds for an Artful Possibilities workshop for kids with disabilities (location TBD prior to funding); funds for printing a local LGBT community calendar with images of non-gender conforming individuals; and \$250 for a pop-up quilting event. Non-funded projects included those that requested money for travel, software, etc. The completed committee score sheets are kept on record. York writes letters of notification.	Bosman moved, Kass seconded, & the Commission unanimously voted.	The four recommended projects were approved for funding.
	Williams said Town needs to help others learn to make proposals for such programs as right now the same artists are proposing all the time. Cefalo recommended holding application workshops open to the public. Orr said maybe applicants should be required to be at selection meeting to answer questions and learn how process goes. Williams said for this small amount of money, applicants shouldn't have to attend selection meeting, but they should attend the application workshop. A requirement could state that artists cannot apply for three years after receiving an award.	None	None

North Carolina Museum of Art / Sculpture Visions	Cefalo described the Exhibition committee's visit to the museum and ideas for focusing future Sculpture Visions art on a specific theme, with consolidated sections or venues. NCMA staff liked Bolin Creek trail as a venue, as well as the Library's Pritchard Park trail, and they recommended an event with increased awards and duration (18 instead of 12 months), possibly with a rolling change where some pieces carry over and others don't.
