#### **PERFORMANCES**

<u>Time Machine</u> (electronic media performance with Bill Brown) RT: 60 minutes

Time Machine is an interactive Live Cinema performance by Gruffat and Brown that uses the metaphor of a time machine to explore storytelling and narrative strategies across a variety of different interactive media. By exploring the varieties and meanings of human interactions with analog and digital technologies, *Time Machine* considers ways to access history and memory, to encourage productive play, and both to reveal and share the process of live media production with each other as well as with an audience.

Time Machine is an extension of our work with single-channel film and video, as well as our shared interest in performance and interactive media. It is also a response to a world that is becoming increasingly screen-based. This project is an attempt to reconnect the screen world with the real world by exploring the role of human action and agency in using and responding to technology. As New Media artists, we are interested in technologies that scale space to the human form, and that measure time in terms of human memory and imagination. We are most excited by a New Media practice that proposes a humanistic approach to technology: that gives us access to our memories; that engages and extends our bodies; and that allows us to conjure up impossible new worlds, temporary utopias that, perhaps, can transform our real times and real spaces.

Reminiscent of the do-it-yourself approach of the Riot Grrrl movement, two feminist provocateurs take their multimedia show on the road. Mary Billyou and Sabine Gruffat present "The Free Translators" touring east coast cities and towns with a program of radical videos and two performances.

As the title suggests, the "Free Translators" video program is inspired by known texts. The artists perform in many of their own videos sometimes enacting the news, dictating words written by the Marquis de Sade or excerpting from Virginia Wolfe's anti-war essays. By rereading the texts for the audience, the videos explore notions of identity and communication, re-imagining issues raised by feminist consciousness and the diminishing space of citizenship amidst the monologue of mass media.


