

## TERMS AND CONDITIONS OF SALE

### WARRANTY DISCLAIMER:

The function of the Certified Budwood Program is to obtain deciduous fruit tree varieties that are true to type, free of known viruses and virus-like agents, and to establish and maintain them for subsequent propagation. Appropriate production and processing procedures are applied by PICO personnel in order to maintain the highest possible health status of material, to prevent mechanical errors, and to provide safe shipment. The CFIA of Agriculture & Agri-Food Canada regularly inspects material from the Certified Budwood Program.

There are no expressed or implied warranties of any kind connected with plant material maintained or distributed by PICO, and specifically, there is no warranty, expressed or implied, as to trueness to variety or type, performance, productivity, merchantability, freedom from virus, virus like agents, or genetic abnormalities.

Recipients when they request plant material from PICO acknowledge that the material is provided "as is" with all desirable characteristics and faults. The recipients are solely responsible for determining the suitability of the material for any particular purpose, and for propagating and handling the material so that it may reach it's greatest potential.

This disclaimer of warranty also applies to plant materials that originated with PICO if they are sold or re-conveyed in any way to a 3rd party. It is the sole responsibility of such seller or re-conveyer to make known the conditions of this disclaimer to a 3rd party.

### CLAIMS:

Any material that does not meet with customer satisfaction due to condition or quantity should be inspected by an accredited Horticultural Specialist, Packing House Fieldsman or PICO representative and send written notification of claim to PICO within 7 days of receipt of material. PICO will not consider any claim for plant material that has been: processed, propagated, planted, modified, or improperly stored. Where reasonable, arrangements will be made for replacement or credit. At no time will PICO be held responsible for claims on any more than the purchase price of the material.

Failure of scion material will only be considered for replacement within 1 year from date of receipt of wood. PICO provides viable wood to be used in propagation and is not responsible for total tree loss or tree failure once a tree is propagated.

### PAYMENT:

PICO's terms of payment are NET 30 days from date of invoice. An invoice will be mailed pursuant to the 7 day period following receipt of material by the customer. Subsequent shipments will not be allowed if a customer's outstanding account remains unpaid. Interest is charged on overdue accounts at an annual rate of 18% compounded monthly from due date. US shipments are to be paid in US funds. All orders are subject to the GST, including royalty charges.

### PRICES:

This price list supersedes and cancels any previous price list. PICO reviews this list annually. Extra charges are required for special or unusually labour intensive orders.

### CANCELLATIONS:

PICO reserves the right to apply a cancellation charge or restocking fee.

### SHIPPING:

All material is shipped at the buyer's risk and expense including: packing materials, inspection fees, customs brokerage & duty charges, delivery charges (courier, bus, etc.) and any other expense incurred by PICO to ensure efficient processing and shipment of the material.

The office is available for Pick-up Orders on Tuesdays and Thursdays between the hours of 10AM and 3PM. Outside these hours please call 494-5157 to arrange a pickup time to ensure someone is available to collect the wood from the cooler.

### RECEIPT & ACCEPTANCE OF SHIPMENTS:

Because of the perishable nature of plant material, all shipments should be immediately and carefully inspected upon arrival and then place in proper storage to maintain freshness.

### PBR, PATENT AND TRADEMARK RIGHTS:

Canadian PBR and US Plant Patent laws prohibit the propagation of protected plant materials for personal use and sale without written permission of the owner or the owner's agent (PICO) prior to top-working or propagating. The use of trademarks without authorization is prohibited. Shipment, delivery, or pick-up of wood from protected plant material is subject to acceptance and signature of PICO's non-propagation or testing agreement.
