Report of Recent Presentations

29 April: "Local Solutions to the Energy Dilemma" (Manhattan)—review speakers and organization. We may have made some good contacts, and verified our suspicion that few communities are doing what we are.

Earth Day Postmortem

Simon hasn't heard back from anyone he spoke to, but he did hand out a number of flyers and spoke to a lot of attendees.

Water Tour

Denise and Kate attended, where they observed the silt pond above the reservoir on Six-mile creek, the water treatment plant on Giles, and waste treatment near Farmers' Market. The plant produces methane in a digester, which gives the plant 20% of their electrical supply. The workers burn the extra methane rather than save it because they make money at the plant and are unconcerned about the increased price of fuel, so therefore don't conserve. Officials are considering the possibility of getting water from Bolton Point rather than Six-mile Creek, because updating the water treatment plant will cost more than pumping water from Bolton. State regulations are stringent and complicated, and even though the

work is complex, there's lots of manual work at the plant. The environment community is and will be influential in the decision-making process; Six-m Creek is protected as a result of the water treatment plant, which might not be the case were the City to move the plant (at which point the land might be broken up and sold to individuals). Denise will look into the political aspects of the situation; Josh will compile list of allies. **(AI)**

We discussed formatting ideas for the white papers, including restricting ourselves to a 10th grade reading level. Jen supports keeping the approach simple. Simon recommends a journalistic approach. Jon thinks we'll know it when we see it. Simon strongly urges us to avoid corporate and bureaucratic language.

The guidelines under development call for further discussion of style sheets: electronic or otherwise. A discussion of style guides led us to agree to look at guides in an effort to find one we can agree to use. **(AI—all.)**

Conference Update

Bethany and Jon shared concerns about organizing a fall peak oil conference. T

group discussed the pros, cons, and likelihood of siphoning off energy from the research and writing project for the sake of the conference. The consensus was to postpone until next spring or fall. We could pitch it as a gathering of central New York, as in a convergence or congress—birds of a feather. In the meantime we might be able to promote a local Peak Oil October Fest with a poster session. We'll review the idea in July, but find potential rooms beforehand.
